Sealed bids will be received by the Village of Mechanicsburg, 18 N. Main Street, Mechanicsburg, Ohio 43044 at said offices until 3 P.M. on FRIDAY AUGUST 9, 2024 for the above-identified project. No late bids or FAX bids will be accepted.

PROJECT SCOPE

The project work shall consist of pavement planning, overlay and base repair as provided for in the scope of work and related appurtenances and equipment, including all labor, materials and equipment necessary to complete the construction in accordance with the Contract Documents.

Each bid shall be accompanied by a Bid Guaranty and Contract Bond as required by Section 153.54 of the Ohio Revised Code in an amount equal to the sum of the bid submitted by each contractor. In lieu of posting the bond, a bidder may use a Cashier's Check, Certified Check or Letter of Credit for ten percent of the Contractor's bid as bid security. When a check or letter of credit is used, the bidder shall be required to post a 100 percent Performance Bond and a 100 percent Labor and Material Payment Bond, upon the signing of the contract.

PREVAILING WAGE

Bidders must comply with the prevailing wage rates on Public Improvements in Champaign County and the Village of Mechanicsburg Ohio as determined by the Ohio Bureau of Employment Services, Wage and Hours Division, (614) 644-2239.

The Village of Mechanicsburg reserves the right to reject any and all bids, and the right to accept the lowest and best bid, the right to waive minor irregularities on any bid, and the right to accept the bid proposal which promotes the best interest of the Village.

Failure to submit the Bid Guaranty Bond with the bid shall be cause for considering the bid submission incomplete and for the rejection of the bid.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed no later than October 31, 2024.

SCOPE

The contractor shall provide the following scope of work including all material, labor, and equipment required to perform the work in accordance with 2023 ODOT specifications. Item 254 Pavement Planing mill out 2" for approximately 1800 L.F. x 28 L.F., prepare surface with ODOT 407 Tack Coat at 0.09 gallons per S.Y. and install 2" ODOT 441 Asphalt overlay and use ODOT 423 Crack Sealing along the curb and at adjoining intersections. The Village wants to keep the millings and the contractor will be required to deliver the millings to a designated site by the Village.

ALT 1 Between approx. 227 Walnut to Race Street

Mill out 4" for approximately 914 LF by 9 LF and install 4" of ODOT 301 Bituminous Asphalt. The bid price shall include milling costs.

ALT 2 Between approx. Race and West Sandusky

Mill out 4" for approximately 588 LF by 9 LF and install 4" of ODOT 301 Bituminous Asphalt. The bid price shall include milling costs.

The Village reserves the right to award the project to the lowest and best bidder and waive any irregularities that it may deem acceptable. Bidders show the price of all the work associated with the base work and ALT 1 and ALT 2.
